### CREATION OF NEW REGIONS AND DIVISION AND RE-DIVISION OF CERTAIN REGIONS INTO CONSTITUENCIES: REGIONAL COUNCILS ACT, 1992

In terms of section 5(3) of the Regional Councils Act, 1992 and pursuant to the report of the Fourth Delimitation Commission, dated June 2013, that has been accepted by me, I hereby –

(a) make known that –

- (i) the Kavango Region has been divided into two regions namely the Kavango East and West Regions and the definitions of the new boundaries of those regions are as set out in the amendments effected to the First Schedule to Proclamation No. 6 of 3 March 1992 (as amended by the Regional Councils Act, 1992, and by Proclamations Nos. 20 of 10 July 1992, 15 of 31 August 1998 and 7 of 28 March 2003) by Schedule I to this Proclamation;
- (ii) the names of the “Caprivi Region” and “Karas Region” have been changed to “Zambezi Region” and “!Karas Region” respectively;

- (iii) a division of the Kavango East and Kavango West Regions and a re-division of the Kunene, Omusati, Oshana, Ohangwena, Oshikoto, Zambezi, Otjozondjupa, Khomas, Hardarp and !Karas Regions into constituencies has been made and the new boundaries and names of the constituencies concerned are as set out in the amendments effected to the Schedule to Proclamation No. 25 of 1 September 1992 (as amended by Proclamations Nos. 42 of 22 October 1992, 16 of 31 August 1998, 35 of 22 November 1999 and 7 of 28 March 2003) by Schedule II to this Proclamation; and
- (b) substitute, in Schedule III to this Proclamation, Schedules 1 and 2 to the Regional Councils Act, 1992, so as to bring those Schedules in line with the changes effected by this Proclamation and previous Proclamations issued under section 5(3) of the said Act.

**SCHEDULE I**

The First Schedule to Proclamation No. 6 of 3 March 1992 is amended as follows:

1. The following item is substituted for the item "REGION NO. 6: KAVANGO REGION":

"REGION NO. 6: KAVANGO EAST REGION comprising the area bounded as follows:

Beginning at the beacon 0001 of the Rundu Townlands No. 1329 on the right bank of the Kavango river, with coordinates latitude 17°53'10" south and longitude 19°42' 24" east, thence southwards along the western boundary of the Rundu Townlands No. 1329 to its south-western beacon 0007 with coordinates latitude 17°58'48" south and longitude 19°42' 28" east, thence eastwards along the southern boundary of the Rundu Townlands No. 1329 to the point with coordinates latitude 17°58'46" south and longitude 19°46'18" east, thence south-eastwards in a straight line to the point in the middle of the Omatako river with coordinates latitude 18°21'52" south and longitude 19°50'13" east, thence generally south-westwards along the middle of the Omatako river to the point of intersection with the regional boundary between the Otjozondjupa and Kavango East Regions, with coordinates latitude 19°10'03" south and longitude 19°28' 36" east, thence eastwards in a straight line along the regional boundary between Otjozondjupa and Kavango East Regions to the point with coordinates latitude 19°10'00" south and longitude 21°00' 00" east, thence northwards along the Namibia and Botswana international boundary to the international beacon No. 25, with coordinates latitude 18°18'50" south and longitude 21°00' 00" east, thence eastwards in a straight line along the said international boundary to the international beacon No. 22, with coordinates latitude 18°18'53" south and longitude 21°27' 18" east, thence north-eastwards along the same international boundary to the point with coordinates latitude 18°07'01" south and longitude 22°30' 57" east, thence northwards in a straight line to the point of intersection with the Namibia and Angola international boundary with coordinates latitude 17°49'19" south and longitude 22°30' 55" east, thence south-westwards along the Namibia and Angola international boundary to the point in the middle of the Kavango river, thence westwards along the middle of that river to the point of beginning".

2. The item "REGION NO. 7: CAPRIVI REGION" is amended by the substitution for the title "REGION NO. 7: CAPRIVI REGION" of the title "REGION NO. 7: ZAMBEZI REGION".

3. The item "REGION NO. 13: KARAS REGION" is amended by the substitution for the title "REGION NO. 13: KARAS REGION" of the title "REGION NO. 13: !KARAS REGION".
4. The following item is added after the item "REGION NO. 13: !KARAS REGION":

"REGION NO. 14: KAVANGO WEST REGION comprising the area bounded as follows:

Beginning at the beacon No. 28 on the Namibia and Angola international boundary with coordinates latitude 17°23'25" south and longitude 18°00' 03" east, thence eastwards in a straight line along the Namibia and Angola international boundary to the international beacon No. 6 with coordinates latitude 17°24'12" south and longitude 18°25'11" east, thence south-eastwards along the middle of the Kavango river to the beacon 0001 of the Rundu Townlands No. 1329 with coordinates latitude 17°53'10" south and longitude 19°42' 24" east, thence southwards along the western boundary of the Rundu Townlands No. 1329 to its south-western beacon 0007 with coordinates latitude 17°58'48" south and longitude 19°42' 28" east, thence eastwards along the southern boundary of the Rundu Townlands No. 1329 to the point with coordinates latitude 17°58'46" south and longitude 19°46'18" east, thence south-eastwards in a straight line to the point in the middle of the Omatako river with coordinates latitude 18°21'52" south and longitude 19°50'13" east, thence generally south-westwards along the middle of the Omatako river to the point of intersection with the regional boundary between the Otjozondjupa and Kavango Regions, with coordinates latitude 19°10'03" south and longitude 19°28' 36" east, thence westwards in a straight line along the regional boundary between the Otjozondjupa and Kavango Regions to the point, with coordinates latitude 19°10'35" south and longitude 19°11' 05" east, thence northwards along the said regional boundary to the point with coordinates latitude 18°48'16" south and longitude 19°12' 08" east, thence westwards along the same regional boundary to the point with coordinates latitude 18°44'06" south and longitude 18°00' 03" east, thence northwards along the regional boundary between the Kavango West and Ohangwena Regions to the point of beginning".

## SCHEDULE II

The Schedule to Proclamation No. 25 of 6 September 1992 is amended as follows:

1. The item "REGION NO. 1: KUNENE REGION" is amended -
  - (a) by the substitution for the paragraph "*Opuwo Constituency*" of the following paragraphs:

*"Opuwo Urban Constituency*

Beginning at the point on the common boundary between the Epupa, Opuwo Rural and Opuwo Urban Constituencies with coordinates latitude 18°00'00" south and longitude 13°40'41" east, thence southwards to the point with coordinates latitude 18°10'40" south and longitude 13°42'34" east, thence south-eastwards to the point in the middle of the D3710 road with coordinates latitude 18°17'14" south and longitude 13°53'09" east, thence eastwards to the common point between the Opuwo Urban, Opuwo Rural and Ruacana Constituencies with coordinates latitude 18°13'39" south and longitude 14°17'49" east, thence northwards along the existing boundary between the Opuwo Urban and Ruacana Constituencies to the common point between the Epupa, Opuwo Urban and Ruacana Constituencies with coordinates latitude 18°00'14" south and longitude 14°16'44" east, thence eastwards to the point of beginning.; and

*Opuwo Rural Constituency*

Beginning at the point on the common boundary between the Epupa, Opuwo Rural and Opuwo Urban Constituencies with coordinates latitude 18°00'00" south and longitude 13°40'41" east, thence southwards to the point with coordinates latitude 18°10'40" south and longitude 13°42'34" east, thence south-eastwards to the point with coordinates latitude 18°17'14" south and longitude 13°53'09" east, thence eastwards to the common point between the Opuwo Urban, Opuwo Rural and Ruacana Constituencies, with coordinates latitude 18°13'39" south and longitude 14°17'49" east, thence southwards along the existing boundary between the Ruacana and Opuwo Rural Constituencies to the common point between the Opuwo Rural, Ruacana and Sesfontein Constituencies, with coordinates latitude 19°00'21" south and longitude 14°22'13" east, thence westwards following the existing boundary between the Opuwo Rural and Sesfontein Constituencies, with coordinates latitude 19°00'30" south and longitude 13°18'54" east, thence northwards to the point with coordinates latitude 18°45'27" south and longitude 13°14'40" east, thence westwards in a straight line to the point on the coast on the Atlantic Ocean, with coordinates latitude 18°44'40" south and longitude 12°19'31" east, thence generally northwards along the Atlantic Ocean to the point with coordinates latitude 18°00'11" south and longitude 11°48'37" east, thence eastwards in a straight line to the point of beginning.; and

- (b) by the substitution for the paragraph "*Sesfontein Constituency*" of the following paragraph:

*"Sesfontein Constituency*

Beginning at the point on the coast of the Atlantic Ocean, with coordinates latitude 18°44'40" south and longitude 12°19'31" east, thence eastwards in a straight line to the point with coordinates latitude 18°45'27" south and longitude 13°14'40" east, thence southwards to the point with coordinates latitude 19°00'30" south and longitude 13°18'54" east, so as to include the Otjikondavirongo and Puros villages in the constituency, thence eastwards in a straight line to the point with coordinates latitude 18°59'58" south and longitude 14°21'53" east, thence generally southwards along the middle of the C35 road to the point with coordinates latitude 19°24'52" south and longitude 14°26'55" east, thence eastwards to the point with coordinates latitude 19°25'05" south and longitude 14°28'26" east, thence southwards in a straight line to the point with coordinates latitude 19°27'56" south and longitude 14°29'17" east, thence south-westwards in a straight line to the point with coordinates latitude 19°30'40" south and longitude 14°27'59" east, thence southwards in a straight line to the point with coordinates latitude 19°33'50" south and longitude 14°28'43" east, thence south-eastwards to the point with coordinates latitude 19°37'35" south and longitude 14°30'35" east, thence south-eastwards to the point with the coordinates latitude 19°40'10" south and longitude 14°34'52" east, thence south-westwards in a straight line to the point with the coordinates latitude 19°44'49" south and longitude 14°32'14" east, thence south-eastwards in a straight line to the point with coordinates latitude 19°45'58" south and longitude 14°34'44" east, thence north-eastwards to the point with coordinates latitude 19°44'30" south and longitude 14°36'05" east, thence south-eastwards in a straight line to the point with coordinates latitude 19°45'19" south and longitude 14°47'32" east, thence south-westwards in a straight line to the point with coordinates latitude 19°47'45" south and longitude 14°39'05" east, thence south-westwards in a straight line to the point with coordinates latitude 19°50'51" south and longitude 14°36'13" east, thence south-eastwards in a straight line to the point with coordinates latitude 19°52'34" south and longitude 14°39'34" east, thence eastwards in a straight line to the point with coordinates latitude

19°52'32" south and longitude 14°42'22" east, thence southwards in a straight line to the point with coordinates latitude 19°57'29" south and longitude 14°44'39" east, thence southwards in a straight line to the point with coordinates latitude 19°59'59" south and longitude 14°45'24" east, thence westwards in a straight line to the point with coordinates latitude 19°59'58" south and longitude 13°02'04" east, thence northwards along the Atlantic Ocean to the point of beginning".

2. The item "REGION NO. 2: OMUSATI REGION" is amended -

(a) by the substitution for the paragraph "*Onesi Constituency*" of the following paragraph:

*"Onesi Constituency*

Beginning at the common point on the boundary between the Ruacana, Tsandi and Onesi Constituencies, with coordinates latitude 17°45'54" south and longitude 14°33'06" east, thence north-eastwards to the point with coordinates latitude 17°44'22" south and longitude 14°36'28" east, thence south-eastwards to the point with coordinates latitude 17°47'09" south and longitude 14°38'03" east, thence north-eastwards to the point with coordinates latitude 17°42'19" south and longitude 14°44'00" east, thence north-westwards to the point with coordinates latitude 17°42'12" south and longitude 14°42'37" east, thence north-eastwards to the point with coordinates latitude 17°39'37" south and longitude 14°44'40" east, thence south-eastwards to the point with coordinates latitude 17°42'23" south and longitude 14°48'50" east, thence north-eastwards to the common point between Outapi, Onesi and Tsandi Constituencies, with coordinates latitude 17°39'45" south and longitude 14°51'25" east, so as to include the Otjimulunga, Okambombona, Oshitumbe, Okaandi, Iilyateko, Oshihindongo and Uukulu villages in the constituency and to exclude the Oshilemba village from the constituency, thence northwards to the point with coordinates latitude 17°38'48" south and longitude 14°50'44" east, thence westwards to the point with coordinates latitude 17°39'05" south and longitude 14°48'44" east, thence westwards to the point with coordinates latitude 17°38'12" south and longitude 14°47'24" east, thence north-eastwards to the point with coordinates latitude 17°37'16" south and longitude 14°48'10" east, thence westwards to the common point on the boundary between the Outapi and Onesi Constituencies with coordinates latitude 17°36'27" south and longitude 14°43'45" east, thence northwards along the said boundary to the point with coordinates latitude 17°34'42" south and longitude 14°43'45" east, thence eastwards to the point with coordinates latitude 17°34'09" south and longitude 14°46'08" east, thence north-eastwards to the point with coordinates latitude 17°32'50" south and longitude 14°47'46" east, thence northwards to the point with coordinates latitude 17°31'21" south and longitude 14°46'55" east, thence north-westwards to the point with coordinates latitude 17°29'43" south and longitude 14°45'01" east, thence westwards to the point with coordinates latitude 17°30'50" south and longitude 14°42'36" east, thence south-westwards to the common point on the boundary between the Outapi and Onesi Constituencies, with coordinates latitude 17°32'22" south and longitude 14°41'29" east, so as to include the Otsingha, Nndiinotya and Oshaana villages in the constituency, thence generally northwards along the middle of the Etaka river to the point on the international boundary of Namibia and Angola with coordinates latitude 17°23'30" south and longitude 14°38'31" east, thence westwards to the point with coordinates latitude 17°23'29" south and longitude 14°32'30" east, thence southwards in a straight line to the point of beginning.;

(b) by the substitution for the paragraph "*Tsandi Constituency*" of the following paragraph:

*“Tsandi Constituency*

Beginning at the common point on the boundary between the Ruacana, Tsandi and Onesi Constituencies, with coordinates Latitude 17°45'54" south and longitude 14°33'06" east, thence north-eastwards to the point with coordinates latitude 17°44'22" south and longitude 14°36'28" east, thence south-eastwards to the point with coordinates latitude 17°47'09" south and longitude 14°38'03" east, thence north-eastwards to the point with coordinates latitude 17°42'19" south and longitude 14°44'00" east, thence north-westwards to the point with coordinates latitude 17°42'12" south and longitude 14°42'37" east, thence north-eastwards to the point with coordinates latitude 17°39'37" south and longitude 14°44'40" east, thence south-eastwards to the point with coordinates latitude 17°42'23" south and longitude 14°48'50" east, thence north-eastwards to the common point between the Outapi, Onesi and Tsandi Constituencies, with coordinates latitude 17°39'45" south and longitude 14°51'25" east, so as to exclude the Otjimulunga, Okambombona, Oshitumbe, Okaandi, Iilyateko, Oshihindongo and Uukulu villages from the constituency, and to include the Oshilemba village in the constituency, thence eastwards in a straight line to the point in the middle of the D3642 road with coordinates latitude 17°38'10" south and longitude 15°02'32" east, thence generally southwards to the point with coordinates latitude 17°50'59" south and longitude 15°03'59" east, thence westwards in a straight line to a point in the middle of the C41 road with coordinates latitude 17°50'59" south and longitude 15°01'51" east, thence south-westwards in a straight line to the point with coordinates latitude 17°55'11" south and longitude 14°59'53" east, thence southwards in a straight line to the point with coordinates latitude 17°59'52" south and longitude 14°59'54" east, thence south-westwards in a straight line to a point with coordinates latitude 18°12'23" south and longitude 14°33'34" east, thence northwards in a straight line to the point of beginning.;

- (c) by the substitution for the paragraph *“Outapi Constituency”* of the following paragraph:

*“Outapi Constituency*

Beginning at the common point in the middle of the C46 road with coordinates latitude 17°30'38" south and longitude 15°00'00" east, thence south-eastwards along the middle of the said road to the point with coordinates latitude 17°31'54" south and longitude 15°01'27" east, so as to include the Nakayale village in the constituency, thence south-eastwards following the middle of the C46 road to the point with coordinates latitude 17°33'51" south and longitude 15°06'10" east, thence south-westwards to the point with coordinates latitude 17°35'20" south and longitude 15°05'24" east, thence southwards to the point with coordinates latitude 17°37'04" south and longitude 15°06'27" east, thence westwards to the common point between the Outapi and Ogongo Constituencies with coordinates latitude 17°37'09" south and longitude 15°02'11" east, thence southwards along the common boundary between the Outapi and Ogongo Constituencies to the common point between the Outapi, Ogongo and Tsandi Constituencies with coordinates latitude 17°38'11" south and longitude 15°02'35" east, thence westwards in a straight line along the common boundary between the Tsandi and Outapi Constituencies to the point with coordinates latitude 17°39'45" south and longitude 14°51'25" east, thence northwards to the point with coordinates latitude 17°38'48" south and longitude 14°50'44" east, thence westwards to the point with coordinates latitude 17°39'05" south and longitude 14°48'44" east, thence westwards to the point with coordinates latitude 17°38'12" south and longitude 14°47'24" east, thence north-eastwards to the point with coordinates latitude 17°37'16" south and longitude 14°48'10" east,

thence westwards to the common point on the boundary between the Outapi and Onesi Constituencies with coordinates latitude 17°36'27" south and longitude 14°43'45" east, thence northwards along the said boundary to the point with coordinates latitude 17°34'42" south and longitude 14°43'45" east, thence eastwards to the point with coordinates latitude 17°34'09" south and longitude 14°46'08" east, thence north-eastwards to the point with coordinates latitude 17°32'50" south and longitude 14°47'46" east, thence northwards to the point with coordinates latitude 17°31'21" south and longitude 14°46'55" east, thence north-westwards to the point with coordinates latitude 17°29'43" south and longitude 14°45'01" east, thence westwards to the point with coordinates latitude 17°30'50" south and longitude 14°42'36" east, thence south-westwards to the common point on the boundary between the Outapi and Onesi Constituencies, with coordinates latitude 17°32'22" south and longitude 14°41'29" east, so as to exclude the Otsingha, Nndiinotyia and Oshaana villages from the constituency, thence generally northwards along the middle of the Etaka river to the point on the international boundary of Namibia and Angola with coordinates latitude 17°23'30" south and longitude 14°38'31" east, thence eastwards in a straight line along the said international boundary to the point with coordinates latitude 17°23'29" south and longitude 14°59'56" east, thence southwards in a straight line to the point of beginning.;

- (d) by the substitution for the paragraph "*Anamulenge Constituency*" of the following paragraph:

*"Anamulenge Constituency*

Beginning at the beacon 10 on the Namibia and Angola international boundary, thence eastwards in a straight line along that international boundary to the point with coordinates latitude 17°23'29" south and longitude 15°07'42" east, thence generally southwards along the middle of the oshana to the point of intersection with the D3608 road with coordinates latitude 17°27'12" south and longitude 15°10'01" east, thence westwards along the middle of that road to the point with coordinates latitude 17°27'26" south and longitude 15°08'45" east, thence southwards to the point with coordinates latitude 17°28'23" south and longitude 15°08'49" east, so as to include the Onekukumo, Oikalakahe, Elonga, Onangombe, Oiheke, Onghili and Onaame villages in the constituency, thence south-eastwards in the middle of the oshana to the point with coordinates latitude 17°37'37" south and longitude 15°16'07" east, thence southwards to the point in the middle of the C46 road with coordinates latitude 17°38'21" south and longitude 15°16'20" east, so as to exclude the Nakayale village from the constituency, thence westwards in the middle of the C46 road to the point with coordinates latitude 17°30'38" south and longitude 15°00'00" east, thence northwards in a straight line to the point of beginning.;

- (e) by the substitution for the paragraph "*Ogongo Constituency*" of the following paragraph:

*"Ogongo Constituency*

Beginning at the common point between the Okahao, Otamanzi and Ogongo Constituencies with coordinates latitude 17°52'27" south and longitude 15°10'53" east, thence northwards to the point with coordinates latitude 17°48'33" south and longitude 15°09'25" east, thence generally westwards to the point with coordinates latitude 17°49'34" south and longitude 15°05'03" east, thence northwards to the point with coordinates latitude 17°46'37" south and longitude 15°04'58" east, thence westwards to the point with coordinates latitude 17°46'29" south and longitude 15°04'06" east, so as to exclude the Omuthitu gwaAmalwa, Okanya, Okaloko and

Ekamba villages from the constituency, thence generally northwards along the common boundary between the said constituencies to the point with coordinates latitude 17°37'09" south and longitude 15°02'11" east, thence generally eastwards to the point with coordinates latitude 17°37'04" south and longitude 15°06'27" east, thence north-westwards to the point with coordinates latitude 17°35'20" south and longitude 15°05'24" east, thence generally north-eastwards to the point in the middle of the C46 road with coordinates latitude 17°33'50" south and longitude 15°06'10" east, so as to exclude the Okapanda, Okapuku, Omakuku and Okahwa ka Ngwedha villages from the constituency, thence generally south-eastwards in the middle of the said road to the point with coordinates latitude 17°38'18" south and longitude 15°16'40" east, thence generally southwards along the middle of the track road to the point with coordinates latitude 17°40'15" south and longitude 15°17'17" east, thence eastward along the middle of the said track road to the point in the middle of the C46 road with coordinates latitude 17°40'05" south and longitude 15°18'51" east, thence southwards in a straight line to the point in the middle of the oshana with coordinates latitude 17°43'45" south and longitude 15°18'52" east, thence generally south-eastwards along the middle of the oshana to the point with coordinates latitude 17°47'15" south and longitude 15°20'56" east, thence generally south-westwards along the track road to Epato to the point of beginning.;

- (f) by the substitution for the paragraph "*Okalongo Constituency*" of the following paragraph:

*"Okalongo Constituency*

Beginning at the point on the Namibia and Angola international boundary, with coordinates latitude 17°23'29" south and longitude 15°07'42" east, thence generally southwards along the middle of the oshana to the point of intersection with the D3608 road with coordinates latitude 17°27'12" south and longitude 15°10'01" east, thence westwards along the middle of that road to the point with coordinates latitude 17°27'26" south and longitude 15°08'45" east, thence southwards to the point with coordinates latitude 17°28'23" south and longitude 15°08'49" east, so as to exclude the Onekukumo, Oikalakahe, Elonga, Onangombe, Oiheke, Onghili and Onaame villages from the constituency, thence south-eastwards in the middle of the oshana to the point with coordinates latitude 17°37'37" south and longitude 15°16'07" east, thence north-eastwards to the point with coordinates latitude 17°37'05" south and longitude 15°16'27" east, thence northwards to the point with coordinates latitude 17°36'10" south and longitude 15°15'40" east, thence south-eastwards to the point with coordinates latitude 17°36'43" south and longitude 15°16'56" east, thence north-eastwards to the point with coordinates latitude 17°36'08" south and longitude 15°18'23" east, thence northwards to the point with coordinates latitude 17°34'04" south and longitude 15°18'52" east, thence generally north-eastwards to the point with coordinates latitude 17°33'03" south and longitude 15°17'40" east, thence eastwards to the point with coordinates latitude 17°33'16" south and longitude 15°20'35" east, thence southwards to the point with coordinates latitude 17°34'29" south and longitude 15°21'46" east, thence generally eastwards to the point in the middle of the Oshikuku to Okalongo road with coordinates latitude 17°33'43" south and longitude 15°22'31" east, thence south-eastwards along the middle of that road to the point with coordinates latitude 17°35'36" south and longitude 15°24'33" east, thence generally eastwards to the point on common boundary between the Etayi and Okalongo Constituencies with coordinates latitude 17°35'02" south and longitude 15°27'14" east, so as to exclude the Oshitende, Oshitalamesho, Opuwo, Oukulamba, Eenkudi, Oshimuti and Omagalanga villages from the constituency, thence generally northwards along the middle of the oshana to the point with coordinates latitude 17°26'40" south and longitude 15°23'01" east, thence eastwards

*Karasburg West Constituency*

point of intersection with a gravel road between Katope and Kankudi with coordinates latitude 17°41'57" south and longitude 18°27' 30" east, thence south-eastwards in the middle of the same gravel road to the point of intersection with the D3406 road at the Kankudi village, with coordinates latitude 17°44'16" south and longitude 18°29'43" east, thence generally south-eastwards in the middle of the road between the Kankudi and Mpengu villages to the point with coordinates latitude 17°46'49" south and longitude 18°36'17" east, thence south-westwards in a straight line to the point with coordinates latitude 18°00'00" south and longitude 18°29'50" east, thence southwards in a straight line to the point on the regional boundary between the Kavango West and Otjozondjupa Regions, with coordinates latitude 18°45'35" south and longitude 18°27'40" east, thence westwards in a straight line along the said regional boundary to the point with coordinates latitude 18°44'06" south and longitude 18°00'01" east, thence northwards in a straight line to the point on the Namibia and Angola international boundary, with coordinates latitude 17°23'24" south and longitude 17°59'59" east, thence eastwards in a straight line to the point in the middle of the Kavango river with coordinates latitude 17°23'23" south and longitude 18°25'15" east, thence south-eastwards along the right bank of the said river to the point of beginning.

#### *Nkurenkuru Constituency*

Beginning on the right bank of the Kavango river at the point with coordinates latitude 17°35'05" south and longitude 18°35' 08" east, thence generally south-westwards in the middle of a track to the point of intersection between the said track and the B10 trunk road between Rundu and Eenhana, with coordinates latitude 17°36'48" south and longitude 18°33' 49" east, thence generally south-westwards in the middle of a track to the point of intersection with a gravel road between Katope and Kankudi villages with coordinates latitude 17°41'57" south and longitude 18°27' 30" east, thence south-eastwards in the middle of the same gravel road to the point of intersection with the D3406 road at the Kankudi village with coordinates latitude 17°44' 16" south and longitude 18° 29' 43" east, thence generally south-eastwards in the middle of the road between Kankudi and Mpengu villages to the point with coordinates latitude 17° 46 '49" south and longitude 18° 36' 17" east, thence north-eastwards in the middle of a track to the north-eastern beacon NK 001 on the right bank of the Kavango river with coordinates latitude 17°41'06" south and longitude 18°41'14" east, thence north-westwards following the right bank of the Kavango river to the point of beginning.

#### *Tondoro Constituency*

between Erango and Davare intersects that straight line, thence north-westwards along the middle of that track road to the point in the Davare village with coordinates latitude 18°09'51" south and longitude 19°13'09" east, thence south-westwards in the middle of a road between Davare and Gcagcawe villages to the point in the Gcagcawe village with coordinates latitude 18°10'13" south and longitude 19°09'19" east, thence westwards in the middle of a track road, thence southwards, generally westwards along the middle of the same track road to the point with coordinates latitude 18°12'40" south and longitude 18°54'27" east, so as to include the Davare, Gcagcawe and Singuruve villages in the constituency, thence northwards in a straight line to the point in the middle of the Kavango river with coordinates latitude 17°49'04" south and longitude 18°55'00" east, thence generally eastwards along the middle of the Kavango river to the point of beginning.

Beginning at the point on the right bank of the Kavango river with coordinates latitude 17°49'17" south and longitude 19°16'11" east, thence southwards in a straight line to the point with coordinates latitude 18°11'00" south and longitude 19°15'00" east, where a track road between the Erango and Davare villages intersects that straight line, thence south-eastwards along the middle of the track road between Davare and Erango, to the point with coordinates latitude 18°10'57" south and longitude 19°15'41" east, thence north-eastwards in a straight line to the point on the common boundary between the Ncamagoro and Rundu Rural West Constituencies, with coordinates latitude 18°05'47" south and longitude 19°29'55" east, thence north-eastwards in a straight line to the point with coordinates latitude 18°04'46" south and longitude 19°37'18" east, thence eastwards in a straight line to the point with coordinates latitude 18°04'48" south and longitude 19°42'32" east, thence northwards in a straight line to the south-western corner of beacon 007 of the Rundu Townlands No. 1329 with coordinates latitude 17°58'48" south and longitude 19°42'28" east, thence northwards in a straight line along the western boundary of the Rundu Townlands No. 1329, to the point with coordinates latitude 17°57'54" south and longitude 19°42'29" east, thence westwards along the airport fence to the point with coordinates latitude 17°57'56" south and longitude 19°42'08" east, thence north-westwards along the airport fence to the point with coordinates latitude 17°57'34" south and longitude 19°42'01" east, thence eastwards along the airport fence to the point with coordinates latitude 17°57'17" south and longitude 19°42'29" east, thence northwards in a straight line to the beacon 0001 on the right bank of the Kavango river with coordinates latitude 17°53'10" south and longitude 19°42'24" east, thence generally westwards following the right bank of the Kavango river to the point of beginning.

#### *Mankumpi Constituency*

Beginning at the point on the common boundary between the Tondoro and Kapako Constituencies, with coordinates latitude 18°11'00" south and longitude 19°15'00" east, thence southwards in a straight line along that common boundary to the point on the regional boundary between the Otjozondjupa and Kavango West Regions, with coordinates latitude 18°48'28" south and longitude 19°12'28" east, thence westwards in a straight line to the point on the regional boundary, where the Tondoro and Mankumpi Constituencies meet, with coordinates latitude 18°47'28" south and longitude 18°55'00" east, thence northwards in a straight line along the common boundary between the Tondoro and Mankumpi Constituencies to the point with coordinates latitude 18°12'40" south and longitude 18°54'27" east, thence eastwards, north-eastwards, eastwards along the middle of a track road going to the Gcagcawe village with coordinates latitude 18°10'13" south and longitude 19°09'19" east, thence generally eastwards in the middle of the road between Gcagcawe and Davare villages to the point with the coordinates latitude 18°09'51" south and longitude 19°13'09" east, thence south-eastwards along the middle of the track road between the Davare and Erango villages to the point of the beginning.

*Ncamagoro Constituency*

Beginning at the point with coordinates latitude 18°11'00" south and longitude 19°15'00" east, where a track road between the Erango and Davare villages intersects a straight line, thence south-eastwards along the middle of the track road between the Davare and Erango villages, to the point with coordinates latitude 18°10'57" south and longitude 19°15'41" east, thence north-eastwards in a straight line to the point on the common boundary between the Ncamagoro and Ncuncuni Constituencies, with coordinates latitude 18°05'47" south and longitude 19°29'55" east, thence southwards in a straight line to the point in the middle of the B8 trunk road with coordinates latitude 18°10'48" south and longitude 19°29'52" east, thence south-eastwards in a straight line to the point in the middle of the Omatako river, with coordinates latitude 18°34'37" south and longitude 19°42'27" east, thence generally southwards, south-westwards in the middle of the Omatako river, to the point on the regional boundary between the Otjozondjupa and Kavango West Regions, with coordinates latitude 19°54'36" south and longitude 19°28'13" east, thence westwards in a straight line along that regional boundary between the Otjozondjupa and Kavango West Regions to the point with coordinates latitude 19°10'00" south and longitude 19°12'14" east, thence northwards in a straight line along the same regional boundary to the point with coordinates latitude 18°48'28" south and longitude 19°12'28" east, thence northwards in a straight line to the point of beginning.

*Ncuncuni Constituency*

Beginning at the south-western corner beacon 007 of the Rundu Townlands No. 1329, with coordinates latitude 17°58'48" south and longitude 19°42'28" east, thence eastwards in a straight line along the southern boundary of the said townlands to the point with coordinates latitude 17°58'46" south and longitude 19°46'18" east, thence south-eastwards in a straight line to the point in the middle of the Omatako river, so as to include the Cuma and Mbumbi villages in the constituency, with coordinates latitude 18°21'52" south and longitude 19°50'13" east, thence south-westwards along the middle of that river to the point, where the Ncamagoro, Mashare and Ncuncuni Constituencies meet, with coordinates latitude 18°34'37" south and longitude 19°42'27" east, thence north-westwards in a straight line along the boundary between the Ncamagoro and Ncuncuni Constituencies to the point in the middle of the B8 trunk road with coordinates latitude 18°10'48" south and longitude 19°29'52" east, thence northwards in a straight line along the boundary between the Ncamagoro and Ncuncuni Constituencies to the point with coordinates latitude 18°05'47" south and longitude 19°29'55" east, thence north-eastwards in a straight line to the common point between the Kapako and Ncuncuni Constituencies with coordinates latitude 18°04'46" south and longitude 19°37'18" east, thence northwards in a straight line along the boundary between the Kapako and Ncuncuni Constituencies to the common point between the last mentioned constituencies with coordinates latitude 18°04'48" south and longitude 19°42'32" east, thence northwards along the boundary of the above mentioned constituencies to the point of beginning."
